(2) In accordance with the service specification methology as described in ITU-T Recommendation I.130, general service definitions are given in the JT-I250 series (stage 1) of Standards and functional specifications for individual supplementary services such as function allocation to the terminal and network are described in the Q.80 series (stage 2) of Recommendations.(3) Concerning the descriptions of the interactions with other supplementary services, it should be noted that those with the services not yet standardized at this moment may be modified or added at a later stage when they are standardized.
